



Yuba-Sutter Economic Development Corporation on behalf of Yuba County, CA Small Business Economic Resiliency Grant Application – Round 2

All applications must be submitted via email at ysedc@ysedc.org

To mitigate the impact of COVID-19 on Yuba County businesses and their employees, Yuba County has committed up to \$500,000 in one-time funds to create a second temporary Small Business Economic Resiliency Grant Program. The application period will open November 10 and close November 24 or until all funds have been exhausted.

Program Overview

Yuba County, through YSEDC, is offering up to \$20,000 per eligible business in Small Business Economic Resiliency Grants to mitigate the economic impact of COVID-19. All impacted businesses except for ineligible businesses, listed below, are encouraged to make application.

Grant applications will be received until funds have been exhausted. Grant funds may be used to cover the day-to-day operating expenses of the business such as payroll, rent/mortgage, utilities or operating inventory or supplies.

Businesses that previously qualified and received grant or loan assistance from Yuba County are eligible to apply although the total grant funds awarded may not exceed \$20,000 in total, including any previously awarded grants or loans.

Eligibility

Minimum eligibility to receive a grant will be determined on the following basis. Eligible businesses must:

- Have a physical location in Yuba County
- Have been in business since January 2020 (including months when the business was closed to the public due to COVID-19)
- Have majority ownership by an individual whose primary residence is within the State of California
- Not be a national chain or franchise
- Have had at least one employee, including sole proprietors, during the 1st quarter of 2020
- Comply with Americans with Disabilities Act of 1990 and Section 504 of the Rehabilitation Act of 1973
- Be free of Federal liens or judgements or other conditions that would exclude the business, or owner if a sole proprietor, from receiving federal funds, including debarment
- Not be owned by a member or in the immediate family of a member of the Board of Supervisors of Yuba County
- Demonstrate a loss in NET REVENUE March through October 2020 over March through October 2019

Ineligible Businesses

Gambling Establishments, Adult Companies (Adult toys and novelty items, strip clubs, retail and ecommerce for adult sales, and other personal adult services), Petroleum Sales or Distribution, Cannabis-related businesses, Lobbying or Agriculture.

Approval Process

Grant applications will be scored on Need and Economic Impact.

Ranking - 100 total available points

Need – 60 points max

Revenue loss in excess of 25% (i.e. March - October 2019 vs. March-October 2020*	15 points
Revenue loss in excess of 50% (i.e. March - October 2019 vs. March-October 2020*	30 points
Out-of-pocket COVID-related costs in excess of \$400	15 points
Out-of-pocket COVID-related costs in excess of \$1,000	30 points

^{*}Note: Paycheck Protection Program (PPP), Economic Injury Disaster (EIDL), other federal stimulus grants, and previous Yuba County economic resiliency grants will be considered revenue for purposes of calculation of loss

Economic Impact – 40 points max

0-4 employees	5 points
5-10 employees	10 points
10-plus employees	20 points
Gross payroll – less than \$50,000	5 points
Gross payroll - \$50,000 - \$99,999	10 points
Gross payroll – more than \$100,000	20 points

Application Period

Grant applications will be received until available funds have been exhausted.

- 2019 Federal Tax Return
- Profit and Loss Statements (Income/Expense) for March through October 2019
- Profit and Loss Statements (Income/Expense) for March through October 2020
- Receipts or estimates for COVID-19 related expenses (plexiglass, signage, outdoor dining equipment, etc.)

If selected to receive a grant, applicant may be required to provide additional documentation.

Yuba-Sutter Economic Development Corporation understands and supports the public's right to access public records. Information submitted through this application is a public record and may be subject to disclosure under the California Public Records Act (PRA). In addition, YSEDC may be required to disclose information submitted through the application by some other legal process, for example, a subpoena.
